Rich Valley Township McLeod County, Minnesota

RESOLUTION DESIGNATING THE FIRST TUESDAY AFTER THE MONDAY IN NOVEMBER AS THE TOWN GENERAL ELECTION DATE.

WHEREAS, Minn. Stat. δ 205.075 provides towns the option to designate the first Tuesday after the first Monday in November of the even numbered year as the date of the town general election; and

WHEREAS, the town board determines that changing the town's general election day from March to November serves the public's interest by aligning the town's election with the other November elections and;

NOW, THEREFORE, BE IT RESOLVED, that the town board of Rich Valley Township, Mcleod County, Minnesota does hereby designate the first Tuesday after the first Monday in November of even-numbered years as the date of the town general election; and

BE IT FURTHER RESOLVED, that the designation shall take effect for the 2008 town election provided the electors vote to authorize the designation at the next town election; and

BE IT FURTHER RESOLVED, that the following plan shall be used to provide an orderly transition to the November election schedule by lengthening the terms of office:

Supervisor A or Don Lhotka's position shall be in the Supervisor's position elected at the March 2006 township election. That term shall be extended to be on the ballot in November 2010, with an expiration date of the first business day in January, 2011. Beginning with the 2010 election, all subsequent terms of office shall be for four years.

Bob Novak, Supervisor B, shall be in the supervisor's position currently scheduled for the election at the March 2007 election. This term shall be extended so as to be on the ballot in November 2008, with an expiration day of the first business day in January 2009. Beginning with the 2008 election, all subsequent terms of office shall be for four years.

Jim Popelka, Supervisor C, shall be in the supervisor's position currently scheduled for election at the March 2008 election. This term shall be extended so as to be on the ballot in November 2008, with an expiration date of the first business day in January 2009. Beginning with the 2008 election, all subsequent terms of office shall be for four years.

The Clerk shall be the position elected at the March 2006 township election. That term shall be extended to be on the ballot in November 2010 with an expiration date of the first business day in January 2011. Beginning with the 2010 election, all subsequent terms shall be for four years.

Bill Schaeve, Treasurer, shall be in the treasurer's position currently scheduled for the March 2007 election. This term shall be extended to be on the ballot in November 2008 with an expiration date of the first business day in January 2009. Beginning with the 2008 election, all subsequent terms shall be for four years.

BE IT FURTHER RESOLVED, that the officers elected after the effective date of the resolution and approval of the town electors shall be elected for four tear terms as provided in Minn. Stat. δ 367.03, sbd. 4; and

BE IT FINALLY RESOLVED , that the town Clerk is her prepare the ballot question and take such other actions a question of adopting the November election date to the town election.	as may be needed to submit the
